The Houston Symphony continues its second century as one of America's leading orchestras with a full complement of concert, community, education, and recording activities. Today, with an operating budget of \$34.325 million (FY23), the full-time ensemble of professional musicians presents more than 130 concerts annually, making it the largest performing arts organization in Houston. After suspending concert activities in March 2020 and cancelling the remainder of 2019-20 events due to the COVID-19 pandemic, the Symphony resumed activities in May 2020, opening the 2020-21 Season on schedule in September 2020. The 2021-22 season saw the full orchestra back onstage at Jones Hall in front of audiences restricted only by the auditorium's seating capacity.
