Guest conductor Lucas Waldin lead the orchestra and vocal soloists in rafter-shaking diva anthems; Steven Reineke and the orchestra were joined by Tony DeSare for "Swingin' Sinatra: A New Year's Celebration," by the Marcus Roberts Trio for a new take on Gershwin's Rhapsody in Blue, and by Crystal Monee Hall and Josh Sklair for "At Last! A Tribute to Etta James." Steven Reineke also led a program of contemporary Broadway hits before closing the season with "The Music of Star Wars" that included music from all nine Star Wars films.

Our goal is to remove economic and geographical barriers to music so that Houstonians from all walks of life can benefit from the art form. Traditionally, Houston Symphony Education and Community Engagement programs serve nearly 200,000 Houstonians of all ages and backgrounds each season, and these activities represented an investment of \$5.0 million, or more than 13% of the annual organization budget, during the 2023-24 Season.
